- notifying SA Water of any safety concerns, new risks not previously identified prior to undertaking an activity, incidents or new misses, and suggested improvements
- consent to photographs and/or videos being taken during an activity which may be used by SA Water for promotional purposes - if you do not wish for this to occur, we ask that you notify SA Water
